

NEW RULE = NO VEHICLES entering vendor area until AFTER completion of the 8:00 fireworks show and the crowd has thinned. Kids are running freely, watching the fireworks and not expecting cars. We DO NOT want an accident. IF you sell out or leave PRIOR to ending of fireworks, you MUST walk everything out of festival area or leave and come back to pick up booth area. No grills/trailers are to be moved prior to ending of fireworks. Violators will not be able to attend in future.
